### Pupil Premium Report 2015-16 and Action Plan 2016-17

July 2016

Beckley Church of England School is a small school with 102 pupils. (National average 263)

In 2015-16, 11% of pupils were eligible for pupil premium or who have been eligible for FSM in the past six years. (National average is 26.6%)

#### **Introduction about Pupil Premium**

The Pupil Premium is additional funding given to schools to:

- Raise the attainment of disadvantaged pupils and close the gap between them and their peers.
- Support children and young people with parents in the regular armed forces.

The Pupil Premium is allocated to schools for pupils, in Years R to 11, that are known to be eligible for free school meals (FSM) or who have been eligible for FSM in the past six years (Ever 6).

#### Barriers to learning 2016/7

The effectiveness of phonics teaching has not been consistently good. Results for last year were below the national average at 71.4%. Boys performed significantly below the national average with 57%.

#### Objectives 2016/7

Our key objective in using the Pupil Premium Grant is to narrow the gap between pupil groups.

The percentage of boys achieving the national average in Year 1 phonics should be in line with the national average.

To ensure that children in KS2 make expected progress in reading.

To increase the percentage of higher ability children (from KS1) working at greater depth in KS2.

To increase the percentage of children taking part in residential trips.
